## **An Update on Our COVID-19 Response Work**

The Hartford Foundation's **COVID-19 Response Fund** has made more than 200 grants and distributed nearly **\$9.5 million** since the start of the pandemic. The fund initially focused on basic human needs as a result of health and economic impacts of the pandemic, and then transitioned to supporting a variety of reopening costs for nonprofits, including PPE, cleaning costs, technology and minor building enhancements.

**As the crisis evolves, so does our work.** In 2021, the COVID-19 Response Fund will make investments on a rolling basis. Examples of potential grant areas include:

- Vaccine education, outreach and distribution to reach residents who may be hesitant to get vaccinated.
- Systemic approaches to help students catch up on lost learning with a focus on reducing inequities.

As always, we will consider many factors when making grants, including disparities addressed, targets populations expected to benefit, overall impact on Greater Hartford residents and more.

Our **application process** for this new phase of the COVID-19 Response Fund will open on February 2.

## **\$500,000 Grant Will Support Free Child Care for Hartford Public School Students**

The Hartford Foundation and the City of Hartford have partnered to offer free child care for approximately 300 Hartford students at Learning Hubs throughout the city. This program will provide much needed support to families who are struggling with work, child care and remote learning during the pandemic. City staff will work with schools to identify students and parents with the greatest need, including priority access for teachers.

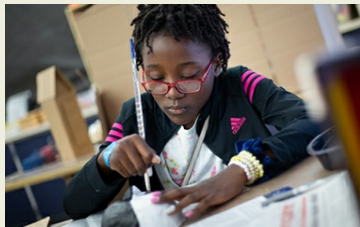
